DETERMINING DENSITY (POUNDS PER CUBIC FOOT)

Rectangular, elliptical, or square-shaped articles:

Multiply length x width x height (in inches) of the article and divide by 1,728 cubic inches (one cubic foot).

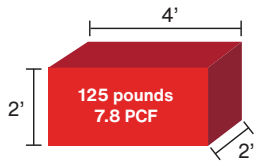
Divide the weight of the article by the ascertained cubic feet.

DETERMINING DENSITY (POUNDS PER CUBIC FOOT)

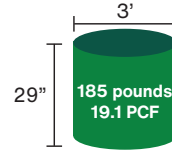
Cylindrical or other than square shaped article:

Square the greatest dimension (diameter) of the article, multiply the result by the height or length, and divide by 1,728 cubic inches (one cubic foot).

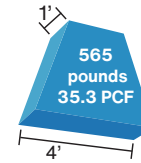
Divide the weight of the article by the ascertained cubic feet.



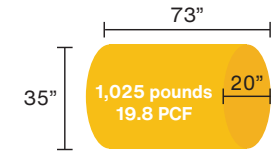
$24'' \times 24'' \times 48'' = 27,648 \div 1,728 = 16$ cubic feet
125 pounds $\div$ 16 cubic feet = 7.8 PCF



$24'' \times 24'' \times 29'' = 16,704 \div 1,728 = 9.7$ cubic feet
185 pounds $\div$ 9.7 cubic feet = 19.1 PCF



$48'' \times 12'' \times 48'' = 27,648 \div 1,728 = 16$ cubic feet
565 pounds $\div$ 16 cubic feet = 35.3 PCF



$35'' \times 35'' \times 73'' = 89,425 \div 1,728 = 51.8$ cubic feet
1,025 pounds $\div$ 51.8 cubic feet = 19.8 PCF
